BEHIND ON RENT OR MORTGAGE PAYMENTS DUE TO COVID-19? -- The Governor's Office for Emergency Relief & Recovery has announced the New Hampshire Housing Relief Program, an initiative designed to keep people from losing their housing and to secure or maintain permanent housing in partnership with the Community Action Partnership for NH (CAPNH). SELF-EMPLOYED LIVELIHOOD FUND (SELF) APPLICATIONS OPEN JULY 6 -- The Self-Employment Livelihood Fund will be capped at \$50,000 for qualifying business people. **Applications will be accepted from July 6 to July 17 from those meeting the following criteria**:

- self-employed businesses must be located in New Hampshire,
- the owners must be the only employees, and it must be a for-profit business,
- the business cannot be permanently closed not including temporary closure due to COVID-19;
- it cannot be in bankruptcy,
- the business must have had gross receipts in 2019 of less than \$1 million.

- HOLIDAY TRASH COLLECTION -- Trash collection on THURSDAY for those with normal pickup on Friday, due to the July 4th holiday.
- **NEW BULKY WASTE DISPOSAL FEES** The fees charged for bulky waste disposal are as follows: \$5 for each box spring, clothes dryer, clothes washer, dishwasher, mattress, propane tank (20# or more), tire or piece of upholstered furniture; \$10 for each cooking range or piece of electronic equipment; and \$20 for each refrigerator or item containing Freon. For curbside collection there is a pick up fee of \$5 in addition to the fees per bulky waste item collected. Curbside customers must schedule the curbside pickup of their bulky waste with DPW in advance and should not place the waste curbside without scheduling a collection. - **REOPENING PORTSMOUTH PROJECT LANE ADJUSTMENT** Partial street closures are now in effect on Penhallow and Market Street in front of Portsmouth Brewery, in addition to Pleasant (between Court and State), Market (opposite Commercial Alley) and the Worth Lot parking spaces close to the Congress Street-side buildings.
- HANOVER ST./TANNER/PARKER ST. PAVING -- Pavement milling (removal of top layer only) continues on Tanner, Parker & Tanner Court to get ready for paving the entire area on Tuesday, July 7, weather permitting. Striping will follow a few days after paving.
- **PORTSMOUTH WATER SUPPLY STATUS REPORT** -- Due to the dry weather and below normal precipitation in May and most of June, the U.S. Drought Monitor elevated the southern half of the state to "Moderate Drought" conditions as of June 23, 2020. However, on June 30th Portsmouth received three inches of rain, which will help our conditions considerably. It also reduced water demand from a high of 6.15 million gallons delivered on June 21, 2020 to only 3.50 million gallons on June 30. Each reservation allows a one-hour visit between 11 am and 7 pm, with 30 minutes between each session to allow for cleaning and sanitizing. CITIZEN RESPONSE TASK FORCE

• **Subcommittee for Arts/Restaurants Popup** – The subcommittee is working with City departments and the arts non-profit RooftopPopup.org to reposition the 'popup' on the Bridge Street parking lot rather than on the top of Foundry Place Garage. Design and permitting discussions continue while the non-profit reports receiving \$81,000 in donations to match this project's share of the Reopening Portsmouth funds allocated by the City Council.

- **Downtown Streets Public Realm Spaces for Restaurants** –This subcommittee continues to identify parking spaces that can be separated from through-traffic by concrete barricades. Additions include Penhallow Street and another section of Market Street. Restaurants interested in their use of these "public realm" spaces for outdoor dining on Worth Lot, Congress Street, Market Street, Penhallow and a portion of Pleasant Street are encouraged to file permit requests through City's Viewpoint system (Sidewalk Café Application). https://portsmouthnh.viewpointcloud.com/categories/1082/record-types/6431

SIGNAL UPGRADES** -- Electric Light Company of York, Maine will begin the upgrade to the traffic signals at three intersections along Maplewood Avenue at Deer Street, Hanover Street and Congress Street.
