

CITIZEN RESPONSE TASK FORCE -- Meets every Wednesday at 2 pm to review progress on the objectives outlined at the formation of the Task Force and to review the work of its three subcommittees, working in parallel:

• Streets Subcommittee working on adapting the public realm for use by restaurants for outdoor seating. This subcommittee meets publicly via Zoom on Monday, Wednesday and Friday, as needed. The following locations now have space protected by safety barricades to allow restaurant tables and chairs in parking spaces: Worth Lot (Café Mediterraneo, Maison Navarre, Friendly Toast), Congress Street (Thirsty Moose, Rudi's, The Goat, Jumpin' Jay's, Flatbread Portsmouth), Pleasant Street (Clipper Tavern), Penhallow Street (Cure, Massimo's, Ceres Bakery, Moxie), State/Chapel Street (Fezziwig's, Mr. Kim's), Market Street (Durbar Square, Cup of Joe, Portsmouth Brewery, Portsmouth Gaslight), Bridge Street/Hill Street (Bridge Street Bistro, Dwyer's Pub), Portwalk Place (Row 34).

- Performing Arts Subcommittee working to adapt the Bridge Street parking lot into an outdoor
 performance and restaurant venue with a tentative opening date of July 30. The subcommittee meets
 publicly via Zoom.
- Health Subcommittee making public a dashboard of current data on local conditions relative to the COVID-19 pandemic and community response such as the availability of PPE and mask-wearing. The subcommittee meets publicly via Zoom on Tuesdays at 11 am.

You may submit the one application to cover absentee balloting for both election by checking the boxes for both. ECONOMIC RELIEF RESOURCES:

GOVERNOR'S GENERAL ASSISTANCE & PRESERVATION (GAP) FUND -- The Governor has allocated and authorized \$30 million of CARES Act Coronavirus Relief Funds ("flex funds") to provide emergency financial relief to New Hampshire businesses and nonprofit organizations impacted by the COVID-19 pandemic, who have not been able to access support from other existing state and federal programs.

- Application Period July 21, 2020 August 4, 2020
- Application Verification Period August 5, 2020 August 18, 2020
