

Actions Taken by City Council


- Installation of Rectangular Rapid Flashing Beacons and a crosswalk for pedestrian crossings at the intersection of Middle Street at Aldrich Road.
- 2. Designation of Lincoln Avenue as a bike boulevard.
- 3. Approved moving parking spaces back to the curb and removing outbound bike lane between Cabot Street and Lincoln Avenue.






- Total Responses 290
 - 158 identified themselves as residents or business owners on Middle Street
 - 97 identified themselves as Portsmouth residents
 - 255 total identified as living or working in Portsmouth
 - 48% of respondents stated they use the bicycle lanes
 - 74% of respondents stated they use the pedestrian accommodations

Bike Lane Survey Responses - Positive



- Protected lanes are appreciated. Slower traffic speeds associated with narrower roadway is a welcome bonus.
- Anything the City can do to get people out of their cars is a plus for the environment, the quality of life in Portsmouth, and personal health.
- Like them now, less intrusive, and safer travel mode.
- > Restore protected lanes.

Bike Lane Survey Responses - Other



- ➤ Bike lanes are needed but the way these are done seems confusing.
- ➤ Past lanes with cars parked towards center of road are confusing to drive on.
- There are many more drivers than bikers. Keep priorities in line with use.
- Do away with the bike lanes! This is a main road which leads you to downtown and shouldn't have a bicycle path interfering with driving.
- The removal of the old bike lanes left a very confusing road configuration. Striping needs to be added to clarify where bikes and cars should be.
- > They are dangerous to vehicular traffic
